FOSTER CARE

Foster Care is the temporary placement in your home for a child who has been removed from his/her home due to abuse, neglect, or dependency. The goal for most foster children is to return to their parent(s) when the circumstances that led to the foster placement have been resolved. However, when children cannot return home, they find permanence through adoption, guardianship, or other means.

KINSHIP CARE

Kinship Care is a placement for a child with either an appropriate relative or "like kin".

RESPITE CARE

It is a vital support service to full-time foster parents who do not have natural supports to care for foster children for a needed break. As a respite foster provider, you have the option to care for children according to your schedule and availability.

WFAPA

- WFAPA is a peer driven volunteer-based association that supports and advocates for foster and adoptive parents.
